A summary of the current expenditures for the FY18 and FY20 WBIF grants was submitted to the members. The FY2018 WBIF grant agreement ends on December 31, 2021. Funds are 99% spent to date, and it is anticipated that the grant will be fully spent by the end of year without extension. The FY2020 grant is 10% expended. Luke Johnson, Wright SWCD, informed the committee members that additional funds are allocated for various activities, but disbursements have yet to be finalized. Johnson anticipates closer to 20-30% of the grant to be spent after all allocations have been realized.

2022 TAC Workplan Discussion T. Ostendorf 30 mins

The 2022 work plan for the TAC was presented to the committee for approval. Activities in the annual work plan will follow the FY2020 WBIF grant work plan as the main source of available funding. Future annual work plan activities may reflect additional fund sources, such as 319 small watershed programs. Committee members discussed the various activities included in the information presented, specifically the promotion and adoption of cover crops and

management practices, as well as outreach efforts that could be enhanced. Policy committee recommended that members gather recommendations for outreach strategies from their respective Boards and bring them for discussion at the March policy committee meeting.
